Instructions for Completing this Form

The selection process for institutional grant aid at the University of Arizona requires financial information from both the FAFSA parent (the parent who you reported on your 2023-2024 FAFSA because they provide more than half of your financial support) and the non-FAFSA parent (the parent who is not on your 2023-2024 FAFSA because they provide less than half of your financial support) to determine a dependent student's eligibility.
