# University of Arizona PharmD Financial Aid Quick Reference Sheet

## **How to Apply for Financial Aid**

- A Free Application for Federal Student Aid (FAFSA) form must be filed each year for Federal Loans or for College of Pharmacy scholarships consideration. The FAFSA form opens annually October 1 for the following school year.
- <u>File the 2024-2025 FAFSA form</u> to apply for financial aid for the Fall 2024 and Spring 2025 semesters. You will use **2022** income tax information when answering questions in the financial section. If you have *never* completed a FAFSA form previously, you will first need to create an <u>FSA ID</u> (your account log in credentials).
- IMPORTANT! Common FAFSA form questions answered incorrectly (and how PharmD students should answer them):

  Question #29 Student's Grade Level in College in 2024-2025: 1st year (or continuing) Graduate/Professional

  Question #30 Type of Degree/Certificate: Graduate/Professional Degree

  Question #47 Working on Master's or Doctorate in 2024-2025? Yes
- The University of Arizona's federal school code for the FAFSA form is 001083.

### Types of Financial Aid Available to PharmD Students

- **Scholarships and Grants:** Are available primarily from the College of Pharmacy. Register with <u>Scholarship Universe</u> to apply for these and other possible scholarship opportunities.
- **Federal Unsubsidized Direct Loans:** PharmD students may borrow up to \$33,000 per academic year. The <u>interest rate</u> for 2024-2025 Unsubsidized loans will be 8.08% (origination/up-front fee of 1.057%). Eligibility is not based on a credit check.
- **Graduate PLUS Loans:** Available to supplement Direct loans and scholarships. They are unsubsidized loans with a 9.08% <u>interest rate</u> for loans borrowed in 2024-2025 (origination/up-front fee of 4.228%). Approval is subject to a credit check by the U.S. Department of Education (ED). The Federal Graduate PLUS Loan will only be denied for adverse credit reasons. See <u>this page</u> for further information. PharmD students should automatically be offered a Graduate PLUS Loan in their financial aid offer. If it is not offered to you and you would like it offered, <u>contact OSFA</u> directly.
- Health Professions Loans (Pharmacy Loans): This is a subsidized loan with a 5% interest rate, intended for low/moderate income families. Eligibility is not based on a credit check. Funds are very limited. To apply for a Health Professions Loan, complete the form at <a href="https://financialaid.arizona.edu/forms">https://financialaid.arizona.edu/forms</a> and submit to OSFA. The 2024-2025 application will be available Late Summer 2024. Applications will not be reviewed until November 2024. The application closes January 31, 2025.
- **Private Educational Loans** are also available. Eligibility is subject to a credit check. Visit our webpage <a href="here">here</a> for additional information about private educational loans.

### **Summer Financial Aid (P3 Students Only)**

Additional Direct Unsubsidized Loans beyond the \$33,000 annual maximum and Graduate PLUS loans are available for designated summer session rotations (after your third year). If you are enrolled in at least 5 summer units and have a 2024-2025 FAFSA form on file, you will be automatically reviewed for the additional Federal Direct Unsubsidized Loan eligibility.

### **Important Reminders**

Your social security number must be in your student record in UAccess for your FAFSA form be loaded by OSFA. Be sure to include it on your application for admission to the PharmD program. If you did not provide your SSN initially, you can provide it now. Instructions for how to update this information in UAccess can be found <a href="https://example.com/here">here</a>.

Monitor personal, financial, and academic information often on <u>UAccess Student Center</u>. View your financial aid summary, complete any items on your *To Do List*, and check for any *Notices & Holds*.
